Subject :- DEPUTATION TO SPECIAL PROTECTION GROUP (SPG): REG.

It is proposed to sponsor eligible and willing officers in the rank of DC(Exe) for deputation to the post of Senior Security Officer (SSO/GD) in Special Protection Group.

- 2. The SDG(APS)/ADsG (North/South) and all Sector IsG are, therefore, requested to forward nominations of willing and eligible officers in the rank of Deputy Commandant/Exe alongwith their bio-data as per <u>Annexure-I</u>, who are fulfilling the following eligibility criteria as specified by SPG as well as MHA's deputation policy dated 22.11.2016 by <u>18.09.2025</u> for necessary action please.:-
 - (i) For the post of SSO/GD
 - 1. Must be a Graduate.
 - 2. Below 35 years of age.
 - (ii) In addition the above, the following criteria are also required:-
 - 1. Clean service records during entire service
 - 2. Must be clear from DE/Vigilance angle.
 - 3. There shall be a minimum cooling off period of 03 years between two deputations, out of which, one year should be in the notified hard areas in case of 2nd time deputation. This shall also apply to the officers who have served on deputation/deployment in UN Peace Keeping Missions abroad and in NSG, SPG & NDRF.
 - 4. Medical category in SHAPE-I.
 - 5. Officers being nominated for deputation will be put through PET by SPG before induction in SPG. There are 05 events as per details in Annexure-II (copy enclosed) and the officers will have to qualify in all these events. Further, SPG have requested that nominated personnel may be imparted training and also advised to prepare

accordingly before appearing in SPG for Pre-Induction test so that the attrition therein can be avoided.

- 3. The following points may be kept in view, while forwarding the nominations to this Directorate:
 - a) Overage candidates should not be nominated.
- b) Candidates who have not completed six months from their last unsuccessful attempt (subject to maximum 03 attempts in entire service) should not be nominated.
 - c) Candidates who have already joined SPG should not be nominated.
 - d) Same candidate may not be nominated multiple times in single nomination.
- 4. Nominations which are not routed through SDG/ADsG / IsG (under ADG/HQrs) concerned <u>or</u> received with incomplete records <u>or</u> received after due date, will be summarily rejected. Nominal roll in respect of eligible and willing officers in the rank of Dy. Comdt(Exe) with willingness certificate may be forwarded in Excel format (using Alt+Enter key in single cell) as per Appendix-A to this Directorate within the stipulated time.
