2	Rank/Pay Level	Directly appointed gazetted officers presently holding the rank of Commandant (Pay Level-13) (which is equivalent to the rank of Sr. Comdt./Exe in CISF), 2I/C (Pay Level-12) (which is equivalent to the rank of Comdt./Exe in CISF) with minimum 10 years of Group A service.
3	Educational Qualification	M.Tech/B.Tech preferably in Electrical/Electronic /Information Communication Technology OR M.Sc in any Science discipline preferably PCM.
4	In-service courses /training.	Preference may be given to those who have undergone any training /course on IEDs / Explosive / PB /VIP Security / handling Technical Gadget etc.
5	Past posting	Preference will be given to officers having field service
6	Disc / Vigilance	Should be clear from Disc/Vigilance angle
7	Service records	Should have clean record of service
8	Medical Category	Should be medical fit (SHAPE-I)
9	Other	The officers so nominated should not have attended PIT / Interview for deputation to any post in SPG during last 3 years.

All Sector IsG are, therefore, requested to forward the nominations of willing and eligible officers alongwith bio-data as per **Annexure-I** and **Annexure-II (for SPG)** to this Directorate by **24.04.2026** repeat **24.04.2026** positively.
