**Subject :- PROMOTION-CUM-POSTING FROM CT/TM (BARBER) TO
THE RANK OF HC/TM (BARBER) FOR THE YEAR -2024**

Reference CISF HQrs (EsttDte-II) SO. No. 145/2024 issued under letter No. E-38023/PCP/Estt-II/2024/3409 dated 23.10.2024.

02. In pursuance of CISF HQrs SO. under reference, CISF personnel as mentioned in Appendix-A has been promoted to the rank of HC/TM (Barber) on regular basis in the pay matrix of Rs. 25500-81100 (for GP-2400, level-4) and posted to the unit/RTC as shown against their names. Their promotion will take effect from the dates, they assume charge of HC/TM (Barber) in the new place of posting. In case no vacancy exists in the rank, they may be adjusted against the similar or higher ranks of the RTCs.

03. It should be ensured before promoting them that they fulfill all the required conditions for promotion as mentioned at Para No. 02 (a to i) of Service order under reference issued by CISF HQrs vide letter No. (3409) dated 23.10.2024.

04. The promotion of CT/TM (Barber) to the rank of HC/TM (Barber) against the year 2024 is subject to order passed on 28.01.2022 by the Hon'ble Supreme Court of India in the case of Jarnail Singh and Ors V. Lachhmi Narain Gupta and Ors, (Civil Appeal No. 629 of 2022) arising out of SLP(C) No. 30621 of 2011 and other connected matters as mentioned in DoPT OM No. 36012/16/2019-Estt (Res-I) dated 12.04.2022.


05. All concerned DIsG are requested to ensure compliance as under:-


