OFFICE MEMORANDUM

Sub: Clarification regarding payment of SCRLA at old rates of 6th CPC where it was admissible, along with Special Duty Allowance (SDA) at revised rate of 10% of Basic Pay, Shall increase by 25% whenever the DA payable on the revised pay structure goes up by 50% or otherwise.

The undersigned is directed to refer to ITBP's UO no. I-22026/02/2024-Org.-7604 dated 03.10.2024 seeking clarification on the above mentioned subject and to say that as per 7th CPC recommendations and MoF(DoE) OM dated 19.07.2017, Special Compensatory (remote Locality) Allowance (SCRLA) has been subsumed in tough Location Allowance (TLA) with an option to employees to continue drawing SCRLA at old rate of 6th CPC along with SDA at revised rate of 10% of Basic pay.

02. In this regard, it is intimated that an employee can draw either TLA or SCRLA with SDA at revised rate of 10% of Basic Pay. Therefore, SCRLA at old rates of 6th CPC, whenever admissible, along with SDA cannot be increased on reaching Dearness Allowance (DA) at 50%.

03. This issues with the approval of Ministry of Finance (Department of Expenditure) vide their ID No. 4/1/2024/E.II B dated 23.12.2024 and concurrence of Integrated Finance Division of this Ministry on Note#28 of efile 3703667 dated 14.11.2024.
